



The Mississippi State University (MSU) Dietetic Internship (DI) program offered in the Department of Food Science, Nutrition, and Health Promotion is a post-baccalaureate program designed to prepare interns for rewarding careers in traditional and non-traditional roles. Interns complete the requirements for the DI and 9 hours of graduate credit within 11 months. The program provides 1200 hours of supervised practice experience in various clinical, research, food service management, community nutrition, and nutrition education settings. Upon completion of the internship, graduates are prepared for the registration examination of the Commission on Dietetic Registration (cdrnet.org), as well as entry-level practice. Graduates may also apply for provisional state licensure once the program verification statements are issued.

## Mission of the MSU DI

The mission of the MSU DI is to provide supervised practice experience which instills in dietetic interns ideals of diversity, citizenship, leadership, and service, and to provide an integrative approach to foods, nutrition, and health and prepare interns who are competent entry-level registered dietitian nutritionists. The program accomplishes this mission through learning experiences in a variety of practice settings with diverse populations, contrasting delivery systems, and research oriented graduate education.

## Goals

1. The MSU DI will prepare graduates who are competent entry-level dietitian nutritionists.
2. The MSU DI will prepare graduates who are leaders and engage in work within diverse populations

## Objectives

1. Based on graduate surveys conducted 3 months post-graduation, 100% of interns will self-rate a competent level of “3-effective” or “4-outstanding” for overall preparation for entry-level dietitian nutritionist (based on 4 point scale).
2. Over a five-year period, at least 80% of first-year test takers will pass the registration exam.
3. At least 90% of interns will complete the program in 150% of the time planned for completion, or 16.5 months.
4. Within 1 year of program completion, at least 80% of graduates seeking employment will have obtained a dietetics-related position.
5. At least 80% of students will receive a rating of “3=Excellent, exceeds expectations” on culminating clinical staff relief rotation evaluations (based on a 3 point scale).
6. At Least 80% or more of employers will respond “3-good” or “4-excellent” that the internship adequately prepared graduates for professional practice.
7. At least 25% of graduates will work with diverse populations in service oriented settings.
8. At least 25% of graduates will obtain leadership or management positions within 5 years post-graduation.

## Graduation and Program Completion Requirements

Interns complete the DI over a 11-month period beginning in July. The Verification Statement is issued upon the successful completion of planned supervised practice rotations. Students will be enrolled in 6 hours of supervised practice and one 3-hour graduate course for the Fall and Spring semesters in addition to 3-hour graduate course during second summer term before beginning supervised practice rotations.

The MSU DI will begin for the 2019-2020 class on July 8, 2019.

However, please be aware that you need to be at the site when preceptors or staff to whom you are assigned requires you to be there. Preceptors and others may not be able and do not need to change their schedules to accommodate your desire to carpool.*



## Admission Requirements

Students must meet the following criteria to be considered for the MSU DI program:

- Completion of a Didactic Program in Dietetics (DPD) with minimum academic requirements as approved by the Academy of Nutrition and Dietetics
- Verification Statement issued by the DPD Director of your college/ university
- Overall GPA of at least 3.00 (strongly recommended)
- GRE scores
- MSU Graduate School admission
- \$35 application processing fee payable to MSU DI and mailed to Dr. Terezie Tolar Mosby

## Application Procedure

Students applying to the MSU DI must apply through the online Dietetic Internship Centralized Application System (DICAS) (<https://portal.dicas.org/>). Applicants must also register for computer matching with D & D Digital at <http://www.dnddigital.com>. The MSU DI participates in matching in the spring only and selects 16 interns.

## Fees and Financial Information

Transportation: Interns must provide their own reliable, sufficiently insured transportation between university and facilities. Some carpooling is possible.

<sup>1</sup>Interns may not schedule additional responsibilities such as assistantships and full-time jobs as they will be working in assigned facilities Monday–Thursday and will have DI class on Friday mornings. Interns will take one graduate class each semester (must take Advanced Clinical Nutrition in summer) in addition to FNH 8286 Supervised Practice Experience.
